Table 1 Key Approvals Required

Respondent Comment

Banana Shire would like to be acknowledged as the Responsible Authority as part of the Building Act (QLD). As such, Banana Shire Council would like to be advised of the site specifics and location of buildings, particularly structures and temporary camps.

Santos Response

Santos has developed an internal site selection criteria model for determining where TAFs will be located as addressed in EIS Section 2.2.3.3. Santos has not yet selected specific sites but is considering several potential options as discussed in EIS Section 3.7.3.25.

Santos is committed to ongoing consultation with affected councils and key stakeholders regarding the site selection and details of the TAFs. Santos will provide required TAF information regarding recreational and entertainment services for workers; utilities on site including electricity and water; waste management including material waste, industrial waste and sewerage, and health and safety provisions. Santos will seek development approvals from the relevant local authorities where necessary.

Respondent Comment

Banana Shire states that the EIS lists the Dangerous Goods Safety Management Act 2001 (Qld) as an approval source for storage and handling of flammable or combustible liquids. Banana Shire Council will be a responsible authority in charge of licensing such facilities. The proponent must advise Banana Shire Council of the proposed storage levels, material types and storages locations, with the view to make applications for a license.

Banana Shire states that the EIS identifies the need for a license to carry out a food business, specifically for canteens located onsite and at temporary camps. Appendix C fails to identify Banana Shire Council as a responsible authority in regards to obtaining food business licenses. Banana Shire Council would like to be acknowledged as a Responsible Authority as part of the Food Act (QLD). As such, Banana Shire Council would like to be advised of the specifics relating to the operation of the food business with the view of obtaining an appropriate license.

Banana Shire states that the EIS identifies the need for approval under the Plumbing and Drainage Act 2002 (Qld) in relation to temporary camps. Appendix C fails to identify Banana Shire Council as a Responsible Authority in regards to a compliance permit for plumbing or drainage work. Banana Shire Council would like to be acknowledged as a Responsible Authority as part of the Plumbing and Drainage Act (QLD). As such, Banana Shire Council would like to be provided with the appropriate plans and other necessary information in order to receive a compliance permit.

Santos Response

Santos will apply, as required, to the Banana Shire Council for any required development approvals including a licence to carry out a food business, a licence to store and handle flammable or combustible liquids and a permit for plumbing or drainage work (if required).
