

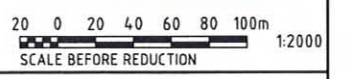

**PHASE 3**

1. ESTABLISH ENVIRONMENT CONTROLS.
2. REMOVE WALL 6 CH 0.00 TO CH 700.00 USING EXCAVATORS AND TRUCKS.
3. CONSTRUCT WALL 6 TEMPORARY SHEET PILE WALL FROM CH 700.00 TO CH 1396.25.
4. CONSTRUCT WALL 3 FROM SHORELINE TO CONNECT TO WALL 6 AT CH 1396.25.
5. CONSTRUCT STORMWATER DIVERSION TO AREA 1.
6. DEWATER AREA 2.
7. DRY EXCAVATE MARINA BASIN IN AREA 2.
  - STOCKPILE TOP 5m OF SOFT MATERIAL ADJACENT TO SHUTE HARBOUR ROAD
  - EXCAVATE MATERIAL TO A DEPTH OF APPROXIMATELY 7.5m BELOW SOFT MATERIAL.
  - DRY, PLACE AND COMPACT EXCAVATED MATERIAL RECLAMATION AREA 2.
8. ENVIRONMENT CONTROL MEASURES INCLUDING, SILT CURTAINS, THE TEMPORARY BUND AND WALL 6 ARE REQUIRED FOR THE CONSTRUCTION TO MEET ENVIRONMENT MANAGEMENT REQUIREMENTS.
9. CONSTRUCTION OF BREAKWATER BW4 AND BWS, FROM BARGE.
10. ENVIRONMENT CONTROL MEASURES INCLUDING WATER QUALITY TREATMENT PONDS AND TESTING ARE REQUIRED FOR THE WORKS TO AREA 2.
11. CONSTRUCT WALL 1 REVETMENT WALL CH 600.00 TO CH 1306.27.
