F. Impacted Properties

This appendix details the properties and interests traversed by the permanent and temporary footprints for the NSW/QLD Border to Gowrie Project (the Project).

Project definitions of relevance to this appendix are as follows:

- Temporary footprint: the area required to accommodate construction activities and facilities of a temporary nature and duration to support the Project. The temporary footprint is generally wider than the permanent footprint to allow for the construction of Project elements including fencing, drainage controls including erosion and sediment measures, temporary stockpiling and soil and vegetation, and to allow necessary construction access and turnaround provisions. Temporary Project facilities include laydowns, site office areas, non-resident workforce accommodation, a material distribution centre, concrete batch plants and borrow pits.
- Permanent footprint: the area required to accommodate permanent infrastructure associated with the Project, including rail, road and other miscellaneous infrastructure. Rail infrastructure includes rail tracks, crossing loops, turnouts, earthworks, bridges, drainage, level crossings, grade separations, rail maintenance access roads, signalling and fencing. Road-related works resulting from the Project encompasses new and upgraded roads, realignments and diversions, intersection improvements and closures.

F.1 Methodology

In identifying and calculating the areas of the properties and interests traversed by the permanent and temporary footprints, geographic information system (GIS) calculations were undertaken utilising the spatial datasets detailed within Table F-1.

The dataset created for the GIS calculations to identify impacted properties consists of the DCDB, modified and combined with survey accurate cadastral data where available. The process of creating this combined dataset consisted of manually realigning lot boundaries to produce a single-level layer of contiguous polygons, honouring the survey accurate cadastral dataset over the DCDB boundaries for spatial accuracy.

In addition to producing the single-level layer of continuous polygons, overlaying parcels were removed from the dataset and interrogated separately to avoid the duplication of areas calculated. This included easement parcels which overlay other land parcels and land parcels with tenure of Land Lease which overlay State Forest tenure. Duplicate lots were also excluded.

When identifying the predominant land use of the impacted properties as mapped by QLUMP, multiple land uses may be mapped within the one allotment. In such instances the land use which takes up the majority of the land within the footprint has been included for the purposes of the impacted properties list.

F.2 Impacted properties

Between the NSW/QLD border and Gowrie the permanent footprint for the Project traverses, in whole or in part, 495 lots and 33 easements. The temporary footprint traverses an additional 86 lots and 9 easements, in whole or in part.

The extent of area associated with these properties within the permanent and temporary footprints, as well as tenure and existing land uses of these properties, are detailed in Table F-2 and Table F-3.

The data presented within Table F-2 and Table F-3 is based on the footprints established for the revised reference design and derived using the datasets listed in Table F-1. Consequently, the outputs in Table F-2 and Table F-3 are not to be used for the land acquisition process.
