As discussed, the State has requested details of QR's progress on the potential upgrades to the Moura system to accommodate rail traffic from the Surat Basin Railway as a part of your EIS documentation.

QR has undertaken some pre-feasibility works on this corridor which provide only very high level indications of upgrades required. A full feasibility study is currently planned for 2009, subject to resolution of commercial matters with mining companies.
